Priorities

1. Registration is guaranteed for all current preschoolers and their siblings until February 10, 2012.
2. Registration opens to Shaare Emeth members exclusively from February 10 – February 24, 2012.
3. Registration opens to the public February 24, 2012.

Previous Financial Obligations

Families of students enrolled in Shirlee Green Preschool must be current in their financial obligation to the preschool and with other charges that may have been incurred.
